## **FAMILY/INDIVIDUAL MEMBERSHIP FEES**

The Initiation fee is \$500 plus 6.25% sales tax.

Monthly Dues are \$140 plus 6.25% sales tax. This includes 250 targets to be used by the member during the month. Additional member targets are \$0.30 per target. Guest targets and any other charges are not included in the Monthly Dues. **Guests may shoot 4 times.** All members will keep a credit card on file and will be billed monthly. Member charges are subject to 6.25% sales tax as prescribed for Waller County, Texas.

No Initiation refunds will be offered. Memberships are not transferable. A Membership includes immediate dependent family members only.

## **CORPORATE MEMBERSHIP FEES**

4 Full Time Employee Minimum:

Initiation Fees: One time \$200 per named employee.

Monthly Dues are \$50 per employee.

Guests may shoot 4 times, per company.

The above Corporate Member's monthly dues and initiation fees will be pre-paid upfront for one year. A 6.25% sales tax as prescribed for Waller County, Texas will be applied.

Corporate members will keep a credit card on file and will be billed monthly. Members will shoot for \$0.30 per target, pay the pickle.

No Initiation refunds will be offered. Memberships are not transferable. A Membership includes immediate dependent family members only.

## **OUT OF TOWN MEMBERSHIP FEES – OUTSIDE A +100 MILE RADIUS**

The Initiation fee is \$500 plus 6.25% sales tax.

Monthly Dues are \$70 plus 6.25% sales tax. Member targets are charged at \$.30 each. Guest targets and any other charges are not included in the Monthly Dues. **Guests may shoot 4 times.** All members will keep a credit card on file and will be billed monthly. Member charges are subject to 6.25% sales tax as prescribed for Waller County, Texas.

No Initiation refunds will be offered. Memberships are not transferable. A Membership includes immediate dependent family members only.

## **BILLING**

1. Members keep a credit card on file. A copy of your bill will be e-mailed to you for approval. Once approved your credit card will be run and a copy can be e-mailed to you.
2. Members having accounts in arrears twenty-five days or more from the statement date will be assessed a finance charge of 1.5% for each month in arrears. Members having accounts in arrears ninety days or more are suspended
3. All charges are the responsibility of the member. The Managers are the ONLY Westside staff members permitted to take payment from member or guests. Westside accepts cash, check and all credit cards.

## **GENERAL RULES**

1. The appearance of your club is important to all members and guests to insure they have a pleasant visit. **All shooters are required to pick up their hulls.** Please do not dispose of any litter (i.e., cans, bottles, paper, cigarettes, cigars, shotgun shell hulls, etc.) except in receptacles provided. Each station is equipped with a trashcan and hull bucket. **No hulls should be left on the ground after shooting.**
2. Members, their family and/or guests are responsible for any and all damage caused to Westside property or equipment. Westside takes no responsibility for any personal injury or loss of property associated with the use of Westside property or equipment. Members are allowed to bring up to four guests at a time per visit. Each individual guest may visit up to four times in one year.
3. Dogs on the course will be at heel or on a leash. Management has the right to request an animal be kennel.
4. No alcohol or drugs prior to shooting. No alcohol will be permitted on the course at any time. This includes spectators.
